The Prosecuting Attorney for the City of Orting, in the name and by the authority of the City of Orting, does accuse the defendant of the crime of Driving While Under the Influence of Intoxicating Liquor or Drug, RCW 46.61.502, committed as follows:

That the defendant in the City of Orting, Washington, on or about 3/21/2010, did operate a motor vehicle in this state while:

- (1) Defendant had 0.08 grams or more of alcohol per two hundred ten liters of breath within two hours after driving as shown by analysis of defendant's breath made under RCW 46.61.506; or
- (2) Defendant had 0.08 percent or more by weight of alcohol in the defendant's blood within two hours after driving as shown by analysis of the person's blood made under RCW 46.61.506; or
- (3) Defendant was under the influence of or affected by intoxicating liquor or any drug; and
- (4) Defendant was under the combined influence of or affected by intoxicating liquor and any drug.

Contrary to CCO 7-1-1 and RCW 46.61.502, and against the peace and dignity of the City of Orting.
